This is a decision on the "APPLICATION FOR PATENT TERM ADJUSTMENT 37 CFR § 1.705(b)," filed March 12, 2007.

The application for patent term adjustment ("PTA") under 37 CFR 1.705(b) is hereby **GRANTED**.

Applicants argue that the patent term adjustment accorded the instant application was improperly reduced 98 days.

The correct patent term adjustment (PTA) at the time of the allowance is 98 days. The Office will adjust the PAIR screen to reflect that the PTA determination at the time of mailing of the instant letter reflects an adjustment of 98 days. A copy of the updated PAIR screen showing the correct determination is enclosed.

Applicants argue that the application is entitled to an adjustment of 340 days in connection with the mailing of the restriction requirement on April 14, 2003, rather than 278 days as previously accorded.

A review of the record reveals that applicants are correct. The application is entitled to an adjustment of 340 days in accordance with 37 CFR 1.702(a)(1) in connection with the mailing of the restriction requirement. The adjustment began May 10, 2002, the day after the date that is 14 months after the date that the application was filed, and ended April 14, 2003, the date that the restriction requirement was mailed. See, 37 CFR 1.703(a)(1).

Applicants have not contested the adjustment of 21 days accorded under 37 CFR 1.702(a)(2) in connection with the mailing of the non-final Office action on November 3, 2003 nor have applicants

contested any of the reductions accorded for applicants' failure to engage in reasonable efforts to conclude prosecution.

Accordingly, at the time of allowance, the application is entitled to an adjustment of 98 days (the adjustment totaling 361 days having been reduced 263 days), as argued by applicants.

The Office hereby acknowledges receipt of the required \$200.00 patent term adjustment application fee.

The patent term adjustment indicated in the patent will include any additional patent term accrued pursuant to \$\$ 1.702(a)(4) and 1.702(b).

The application file is being forwarded to the Office of Patent Publication for issuance of a patent.
