Continuation of 11. does NOT place the application in condition for allowance because: the Applicant argued that the Schmelz reference fails to disclose a device having an interface to an external measuring unit. The Examiner respectfully disagrees, since the Schmelz discloses a subunit 40 determining a NOx rate through the use of the following parameters: air flow rate, charge pressure, and engine speed (see Figure 1, col. 7, lines 57-65). The subunit (40) having connection to the external measuring unit or control unit (38); therefore, Schmelz reference discloses a device having an interface to an external measuring unit. .
