### **DETAILED ACTION**

1. This communication is in response to amendment filed 3/14/08.

#### ***Response to Amendment***

2. Claims 6-10 have been amended and new claim has been added.

#### ***Response to Arguments***

3. Applicant's arguments with respect to claims 6-10 have been considered but are moot in view of the new ground(s) of rejections.

The text of those sections of Title 35, U.S. Code not included in this action can be found in a prior Office action.

#### ***Claim Rejections - 35 USC § 112***

4. Claims 6-10 are rejected under 35 U.S.C. 112, second paragraph, as being indefinite for failing to particularly point out and distinctly claim the subject matter which applicant regards as the invention.

Claim 6 is analyzed as exemplary claim. Similar analysis also applies to claims 7-10.

Claim 6 recites a pattern recognition processor comprising :

- (a) means for “generating a results output” based on a recognition of recognition of one or more patterns of price data and generating a result output, and

(b) means for detecting one or more broadening tops and broadening bottoms .

The claim, however, fails specify (i) on what basis the one or more broadening tops and broadening bottoms are detected by means specified in (b). In other words it is indefinite as to the link of the means of detecting the broadening tops and broadening bottoms to the means of applying the smoothed non-linear relationship generated by the data processor.

The claim furthermore, fails to particularly specify the limitation “ a results output” which without any definition or further explanation is treated merely as an output of some sort and therefore indefinite.

Claims 7-10 are likewise treated as being unclear and indefinite.
