**DETAILED ACTION**

1. This communication is in response to amendment filed 10/30/2008 and subsequent Request for Continued Examination Transmittal filed 12/1/2008.

***Response to Amendment***

2. Claims 6-10 are currently pending and are allowed.

***Continued Examination Under 37 CFR 1.114***

1. A request for continued examination under 37 CFR 1.114, including the fee set forth in 37 CFR 1.17(e), was filed in this application after final rejection. Since this application is eligible for continued examination under 37 CFR 1.114, and the fee set forth in 37 CFR 1.17(e) has been timely paid, the finality of the previous Office action has been withdrawn pursuant to 37 CFR 1.114. Applicant's submission filed on 12/1/08 has been entered.

***Reasons for Allowance***

3. The following is an examiner's statement of reasons for allowance of claims 6-10:

The claimed inventions pertain to a system for processing price data corresponding to a sequence of time for a selected interval and detecting one or more patterns the price data and further generating price movement projections based on a detected one of an identified pattern in the price data.

The closest prior art of record Black (US 6,012,042) teaches a system of combining daily price data with other non-uniform historical data and using this combined data as a vehicle for security assessment. Because Black addresses a fundamentally different issue, it does not provide the requisite teaching of a data processor operable to receive price data corresponding to a sequence of time for a selected interval and to generate a non-linear function having a smooth, curvilinear characteristic for a range of data within said interval by applying to said price data a smoothing estimator whose parameters comprise a bandwidth, a window length, and a lag time. Black further does teach a pattern recognition processor in communication with the data processor operable to receive said data corresponding to said non-linear function, and comprising means for applying analyzing said smoothed non-linear relationship function to discern the existence identify one or

more patterns of price-time data and generating a results output based on a recognition of said one or more patterns.

Another prior closely related to the allowed subject matter is disclosed by Kamijo, K. and Tanigawa, T. (Date: 1990 Country of Publication: USA 3 vol. (908+984+974) pp. Conference Date: 17-21 June 1990) Stock price pattern recognition-a recurrent neural network approach where recurrent neural networks were applied to the recognition of stock patterns, and a method for evaluating the networks was developed.

However, there is teaching or suggestion in this reference of the aforementioned features recited in the allowed claims.

The analysis presented above applies to all pending and allowed claims 6-10.
