

CERTIFICATE OF AMENDMENT TO AMENDED AND RESTATED CERTIFICATE OF INCORPORATION, AS AMENDED OF FREEMARKETS ONLINE, INC.

Pursuant to Section 242 of the Delaware General Corporation Law

FreeMarkets OnLine, Inc., a Delaware corporation (the "Corporation"), hereby certifies as follows:

FIRST: The Certificate of Incorporation of the Corporation was filed in the Office of the Secretary of State of Delaware on March 13, 1995, and a certified copy was recorded in the Office of the Recorder of New Castle County, Delaware. The Certificate of Incorporation was amended on March 22, 1995, was amended and restated on March 29, 1996, was amended on February 26, 1998, and was further amended on June 30, 1999 (as so amended, the "Certificate of Incorporation").

SECOND: The Certificate of Incorporation is hereby further amended by deleting Paragraph I thereof in its entirety and inserting in its place the following new Paragraph I:
