Response to Election/Restriction Requirement, Non-Responsive

In the response to the Election/Restriction requirement on March 08, 2004, applicant asserts that all claims 1-37 are directed to Species 1 (Fig. 1). However, applicant fails to prove that claims 1-37 belong to species 1. It appears some claims do belong to other species. For example, claim 13 directs to species V that is directed to a device with a capacitor means (fig 8). Applicant is required to match each single claim to Fig. 1 if the claim is believed to teach details disclosed in species 1. Since the above-mentioned reply appears to be bona fide, applicant is given ONE (1) MONTH or THIRTY (30) DAYS from the mailing date of this notice, whichever is longer, within which to supply the omission or correction in order to avoid abandonment.
