

EXAMINER'S AMENDMENT

The application has been amended as follows:

Cancel claims 3-5 and 11-15.

Election/Restrictions

This application is in condition for allowance except for the presence of claims 3-5,11-15 to an invention non-elected without traverse. Accordingly, claims 3-5,11-15 have been cancelled.

Allowable Subject Matter

Claims 1,2,6,8-10,16,18-21 are allowed.

The following is an examiner's statement of reasons for allowance:

After reviewing applicant's arguments and conducting an updated search none of the cited prior art references discloses the claimed multi-wavelength surface emitting laser having the recited limitations of independent claims 1,6 and 16, where a first and second laser are formed independent and apart of each other, while sharing a common substrate and lower electrode and each having a bottom reflector disposed on the substrate, an active region disposed on the bottom reflector, an upper reflector formed on the active region and emitting a first and second wavelength.
