REASONS FOR ALLOWANCE

1. The following is an examiner's statement of reasons for allowance: Concerning claims 1-11 & 45-47 there is no prior art that teach or suggest composition comprising a metallic surface which comprises a self assembled monolayer (SAM) comprising a nucleic acid capture probe and the claimed asymmetric monolayer where A is sulfur or phosphonate, MFS is conductive oligomer or insulators and AG is electroconduit forming species and MFS and AG are different.

The closest prior art is Bauer (US6,096,497) who teach a mixed SAM composition but do not teach or suggest oligonucleotides.
