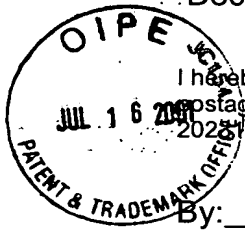


Sir:

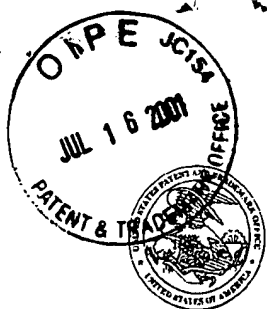


