### **DETAILED ACTION**

## Allowable Subject Matter

Claims 1-13 are allowed.

The following is an examiner's statement of reasons for allowance:

Regarding claims 1 and 13, the prior art fails to teach "modeling the wireless bridge by each real portal in the form of virtual buses and virtual portals, so that the modeled wireless bridge comprises only virtual bridges with a maximum of two virtual portals;", as cited in the claim.
