Continuation of 11. does NOT place the application in condition for allowance because: Applicant's arguments have been fully considered but are not persuasive. Applicant argues in substance that Takagawa does not disclose translating specific commands received by said user station into commands that conform to a first given communication protocol and intercepting a specific command prior to the uppermost layer. In response, Takagawa teaches a method and system where a user inserts a smart card into a smart card reader. The system automatically reads information stored on the card and automatically communicate with communication interface without user intervention and separate from the user browser (see col. 2 lines 1-61) and therefore Takagawa teaches "loading a piece of specialized software forming an interface distinct from the web browser to translate specific commands received by user station". Also Takagawa teaches sending information to a www server and in response receives data and signals from the information processing portion that is later used to provide information to the user using the browser (see col. 4 lines 11-col. 5 lines 15) and therefore Takagawa teaches translating specific commands that conforms to a first given communication protocol and intercepting a specific command prior to the uppermost layer .
