DETAILED ACTION

Allowable Subject Matter

1. Claims 1-14 and 19-25 are allowed.

- 2. The following is a statement of reasons for the indication of allowable subject matter:
 Applicant has corrected, or otherwise traversed, objections to claims 7-8, 19, 21 and 24-25 to
 place the claims in condition for allowance. Prior objections are withdrawn. Reasons for
 allowability of the independent claims above, and therefor their dependents, can be found in
 paper number 13. An additional reason for allowance is that the prior art fails to teach or suggest
 locating the point on a fiber optic link at which a disturbance takes place using the apparatus
 claimed.
