### DETAILED ACTION

The Amendment received 6/28/04 has been entered. Claims 3-27 and 29-32 remain pending in this application. The amendments to the claims and Applicants' Remarks have overcome the rejections recited in the final Office action mailed 1/26/04.

#### *Allowable Subject Matter*

1. Claims 3-27 and 29-32 are allowed; and are renumbered as 1-29.
2. The following is an examiner's statement of reasons for allowance:

Applicants' Remarks, see pages 4-7 of the Amendment received 4/28/03, applicants have clearly pointed out the patentable novelty features and the differences between the amended claims invention and the prior art of record, the Inamori et al Invention (US Patent No. 5,751,278). Specifically, the device comprising "*wherein the computing circuit (33) is a means for generating n pieces of specific patterns each having different spatial frequencies which are weighted based on the picture image signals for every block unit*", see Fig. 6, and claims 3-6,9, 10, 12, 13, 29 and 31.


