DETAILED ACTION

1. This is a response to the amendment, filed 12/6/04.
2. Claims 2-13,16-20,22-24 are pending.

Response to Amendment/Arguments

3. Applicant's amendment and arguments, filed 12/6/04, has been considered and deemed persuasive to overcome the previous rejections to the claims. As to claim 2, Applicant argues that the prior art of record does not teach the claimed hardware memory router, as claimed. This argument is persuasive. Claims 2-13 are allowed for this reason. As to claim 16, Applicant argues that the prior art of record does not suggest the claimed external port for allowing commands for repartitioning the memory by reconfiguring the hardware router. This argument is persuasive. Claims 16-20 are allowable for this reason. As to claim 23, Applicant argues that the prior art of record does not suggest the first component is operable to add a key to the the address specified by the processor request, the key identifying the processor making the request; and wherein the second component is operable to use the key to route the request to the appropriate memory address, wherein multiple processors using the same communication link and using overlapping processor addresses securely access the memory. This argument is persuasive. Claims 22-24 are allowable for this reason.

Allowable Subject Matter

4. Claims 2-13,16-20,22-24 are allowed for reasons indicated above.
