### DETAILED ACTION

#### Continued Examination Under 37 CFR 1.114

1. Receipt is acknowledged of a request for continued examination under 37 CFR 1.114, including the fee set forth in 37 CFR 1.17(e) and a submission, filed on 12/18/2006.

### Priority

2. Acknowledgment is made of applicant's claim for foreign priority under 35 U.S.C. 119(a)-(d). The certified copy has been filed in the pending application.

## Allowable Subject Matter

3. Claims 1-5 are allowed.

The following is an examiner's statement of reasons for allowance:

In reference to claims 1 and 4, the prior art of record (Bodenkamp et al. (U.S. Patent 5,243,447) and Mizuyabu et al. (U.S. Patent 6,297,832 B1)) does not explicitly disclose an onscreen display controller located within a portable mobile telephone for mixing RGB data converted from YUV data stored in a first memory with RGB data read from a second memory and displaying such mixed data on a color display unit of the portable mobile telephone, in combination with the further limitations of claims 1 and 4 respectively.

In reference to claims 2, 3 and 5, claims 2, 3 and 5 depend upon allowable claims 1 and 4 respectively and are therefore also deemed allowable.

The prior art rejection of claims 1-5 has been withdrawn since amendments to claims have specifically directed the limitations, interconnections and interactions of the limitations, towards a portable mobile telephone.
