EXAMINER'S AMENDMENT

In claim 42, line 19, before "indicating" insert:

line 35, change "pulses" to "signals" ;

line 37, delete "those measured by the cycle clock" and

insert therefor: "the crystal oscillator pulses" .

In claim 46, line 15, before "indicating" insert:

"providing said signals to the microprocessor" ;

line 16, after "oscillator" insert:

"producing pulses and " ;

line 17, after "and" insert new lines:

"initiating a 12.5ms long charge to said variable oscillator circuit every 2.5 seconds for the purpose of measuring the operating frequency of said circuit while conserving power as needed for the practical application of the technology in parking control;"

line 28, change "pulses" to "signals" ;

line 30, delete "those measured by the cycle clock" and

insert therefor: "the crystal oscillator pulses" .

Claims 43-45 are cancelled. (Claim 42 indicated as being cancelled at page 8 of amendment is retained).

The following is an examiner's statement of reasons for allowance:


Claims 25, 29-39, 42, and 46-62 are allowed because the prior art does not disclose or suggest an electronic parking meter having a microprocessor controller initiating a 12.5ms charge to a variable oscillator every 2.5 seconds and superimposing the signals from the variable oscillator during each 12.5ms frame with the crystal oscillator pulses, in combination with the remaining elements of each independent claim.
