- The claims 12-15 and 17-24 are allowed as amended over the arguments by the applicants filed 12/09/2003, and the prior art of record that neither teaches nor fairly suggestive of a composition and a method of making nickel mixed hydroxide with Ni as the main element and with a layer structure, specifically with the degree of oxidation ' $\alpha$ ' of the element 'Ma' meeting the limitations of the instant claims by the applicants.
