IN THE CLAIMS

This listing of claims will replace all prior versions, and listings, of claims in the application. Please amend claims 1, 4, 8, and 9 and add new claims 10 and 11 as follows:

Listing of Claims

1. (Currently Amended) A recording system for recording and/or reserving a program, comprising:

means for accepting a request to record and/or reserve a program;

<u>local</u> storage means for recording the program;

connection means for connecting, via a wide area network, with an external device which is external to the recording system;

determination means for determining whether it is possible to record the program requested to be recorded and/or reserved on the local storage means; and

means for issuing a recording substitution request to [[an]] the external device for recording the program, via the wide area network by said connection means, in response to a negative result of said determination; and

user information management means for storing user information about each requesting origin,

wherein a recording substitution means obtains advertising information
appropriate for a user attribute of the requesting origin via said connection means and one of (a)
inserts said advertising information in a recorded program stored in the storage means in addition
to original commercial information included in the recorded program and (b) substitutes said

advertising information for the original commercial information included in the recorded program.

- 2. (Previously Presented) The recording system according to claim 1, wherein said determination means generates a negative result when a remaining capacity of said storage means is not sufficient for recording a program requested to be recorded and/or reserved.
- 3. (Previously Presented) The recording system according to claim 1, wherein said determination means generates a negative result when a failure in said system prevents a program from being recorded in said storage means.
- 4. (Currently Amended) A recording substitution system for substitutionally recording a program, comprising:

connection means for connecting <u>via a wide area network</u> with [[an]] external [[device]] <u>devices which are external to the recording substitution system;</u>

means for receiving a program;

storage means for recording the program;

recording substitution means for responding to reception of a recording substitution request from at least one of the external devices via said connection means and for receiving and recording a corresponding program corresponding to the request in said storage means; and

user information management means for storing user information about each requesting origin,

wherein said recording substitution means obtains advertising information appropriate for a user attribute of the requesting origin from another external device via the wide area network by said connection means and one of (a) inserts said advertising information in a recorded program stored in the storage means in addition to original commercial information included in the recorded program and (b) substitutes said advertising information for the original commercial information included in the recorded program.

- 5. (Previously Presented) The recording substitution system according to claim 4, wherein said recording substitution means can receive recording substitution requests from a plurality of external devices and records a program corresponding to a requesting origin.
- 6. (Previously Presented) The recording substitution system according to claim 4 further comprising user information management means for storing user information about each requesting origin, wherein said recording substitution means records a program in a format appropriate for a user attribute of the requesting origin.
 - 7. (Canceled)
- 8. (Currently Amended) A recording system for recording and/or reserving a program, comprising:

a request accepting portion configured to accept a request to record and/or reserve a program;

a local storage portion configured to record a program;

a connection portion configured to connect, via a wide area network with an external storage device external to the recording system;

a determination portion configured to determine whether the <u>local</u> storage portion contains sufficient space to record a program requested to be recorded and/or reserved; and an issue portion configured to <u>automatically</u> issue a recording substitution request to the external <u>storage</u> device via <u>the wide area network through</u> the connection portion <u>automatically</u> in response to negative result from the determination portion <u>to record the</u> program.

9. (Currently Amended) A recording substitution system for substitutionally recording a program, comprising:

receiving portion configured to receive a program;

a storage portion configured to record a program;

a connection portion configured to connect <u>via a wide area network</u> with [[an]] external device devices; and

recording substitution portion configured to (a) respond to reception of <u>a</u> recording substitution request from <u>at least one of the external devices via</u> said connection portion, (b) receive and record a corresponding program in said storage portion, and (c) one of (1) replace advertising content with new advertising content <u>received from another external</u>

<u>device</u> and (2) insert additional advertising content <u>received from another external device</u> into the recorded program in the storage portion.

10. (New) The recording system according to claim 1,

wherein the external device including user information management means and a recording substitution means; and

said user information management means for storing user information about each requesting origin,

wherein the recording substitution means obtains advertising information appropriate for a user attribute of the requesting origin via said connection means and one of (a) inserts said advertising information in a recorded program stored in the external device in addition to original commercial information included in the recorded program and (b) substitutes said advertising information for the original commercial information included in the recorded program.

11. (New) The recording system according to claim 8,

wherein the external device including user information management means and a recording substitution means; and

said user information management means for storing user information about each requesting origin,

wherein the recording substitution means obtains advertising information appropriate for a user attribute of the requesting origin via said connection means and one of (a) inserts said advertising information in a recorded program stored in the external device in

addition to original commercial information included in the recorded program and (b) substitutes said advertising information for the original commercial information included in the recorded program.
