Continuation of 2. NOTE: Firstly, claim 8 is not pending as it was cancelled by amendment A received 7/18/02. Therefore, this amendment improperly lists claim 8 as "(original)" when it should be canceled. If Applicants wish to reinstate that subject matter, it must be added as a new claim 9. Next, the newly added limitation to claim 1, "to prevent in-phase resonant frequency peaks from conforming to each other" requires further search and/or consideration.
