EXAMINER'S AMENDMENT

Authorization for this examiner's amendment was given in a telephone interview with Dahna Pasternak on February 27, 2004.

The application has been amended as follows:

IN THE CLAIMS:

- Claim 25, replace with the following:

--Claim 25. A method for quantitating replication defective alphavirus replicon particles comprising:

- a) providing a population of packaging cells, wherein all structural proteins necessary for production of progeny of replication defective alphavirus replicon particles are expressed in said packaging cells;
- b) contacting said packaging cells with said replication defective alphavirus replicon particles under conditions suitable and for a time sufficient for said cells to be infected with said replication defective alphavirus replicon particles;
- c) incubating said infected packaging cells under conditions suitable and for a time sufficient for production of progeny of said replication defective alphavirus replicon particles;
- d) enumerating the number of resulting plaques, thereby quantitating said replication defective alphavirus replicon particles.--

- Cancel claim 26.
- Claim 30, replace with the following:

--Claim 30. The method of claim 25, further comprising the step of overlaying said infected cells with a layer of agarose prior to step (c).--

Reasons for Claim Amendments

2. Claim 25 was amended in order to incorporate the limitations of claim 26 into the method steps and further describe the packaging cells. Claim 26 was cancelled because its limitations were incorporated into claim 25. Claim 30 was amended to clarify at what step in the process that the overlaying with agar takes place.

Conclusion

3. Claims 25 and 27-30 as amended above are allowable.
