Re claim 18, line 8: "tag(s)" has been changed to --tag--.

Allowable Subject Matter

3. Claims 8, 10-13 and 18-24 are allowed.
4. The following is an examiner's statement of reasons for allowance:

The prior art of record, Garber and Davidsson, fails to teach accessing a database stored in memory of a removable flash member card of the RFID reader to retrieve information

necessary to categorize each RFID-tagged item based on the information obtained from the RFID tag.

The prior art of record, Garber and Davidsson, fails to teach both selecting at least one category of items and specifying one or more attributes associated with the selected category, and ignoring any RFID-tagged-item without listing or categorizing those items that do not have the attributes specified by the selected category.

Any comments considered necessary by applicant must be submitted no later than the payment of the issue fee and, to avoid processing delays, should preferably accompany the issue fee. Such submissions should be clearly labeled "Comments on Statement of Reasons for Allowance."
