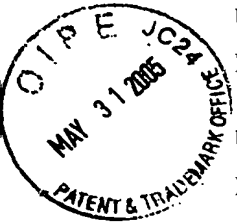

SECOND REQUEST FOR STATUS OF PENDING APPLICATION

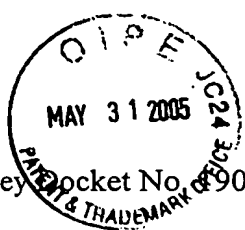
