## **DETAILED ACTION**

### ***Remark***

1. Claims 1-8, 19-23, and 26-50 were canceled in the amendment dated 10/19/05. Pending claims are 9-18 and 24-25 for examination.

### ***Allowable Subject Matter***

2. Claims 9-18 and 24-25 are allowed.

### ***Reasons for Allowance***

3. The following is an examiner's statement of reasons for allowance:

Regarding claims 9 and 24, the prior art of record fails to teach or suggest a digital broadcasting apparatus, wherein the apparatus comprising image storage means, control information storage means, correspondence information storage means, multiplexing transmission means which further includes a retrieval unit, a multiplexing unit, and image correspondence table generation unit, and an image correspondence table multiplexing unit for reading an image correspondence table according to a set of image data and multiplexing the image correspondence table in a manner that the image correspondence table will be transmitted by the multiplexing transmission means at a time which precedes a transmission of the corresponding set of image data by at least a predetermined time period, and the time is pre-defined as called for within the claims.
