

STATEMENT OF FACTS

1. The Examiner issued a Notice of Abandonment in the subject application because Applicant failed to pay the required issue fee and publication fee as indicated in the Notice of Allowance mailed on January 13, 2005.
2. Applicant did not receive the Notice of Allowance mailed on January 13, 2005 because the notice was addressed to a party that is no longer responsible for the prosecution of this application.
3. Applicant filed a Revocation of Power of Attorney and Change of Correspondence Address on February 4, 2004 indicating that all communications concerning the application should be sent to Steven P. Skabrat, c/o Blakely, Sokoloff Taylor and Zafman LLP (hereafter BSTZ). Applicant received a return receipt postcard from the Office, which indicated that the Change of Correspondence Address was received on February 6, 2004.
4. When BSTZ accessed the PAIR system on June 15, 2005 to determine the status of the application, it was discovered that the Notice of Allowance had been mailed to an address other than that specified in the Change of Correspondence Address, and that the application had subsequently been abandoned for failure to pay the issue fee.

REMARKS

Applicant respectfully requests that the holding of abandonment in the subject application be withdrawn and that the application be allowed to issue, since Applicant did not receive the Notice of Allowance due to the non-processing of the Change of Correspondence Address received by the Office on February 6, 2004.
