

Examiner's Statement of Reasons for Allowance

1. This office action is in response to the amendment filed on May 30, 2007.
2. Applicant amended claims 1, 4, 6, 19, 22, 24, 37, 40, 42, 65, 67, 70, 73, and cancelled claims 2, 5, 10-16, 20, 23, 28-36, 38, 41, 46-64, 68, 69, 71, 72, 75-116, and 118.
3. Claims 1, 3, 4, 6-9, 17-19, 21, 22, 24-27, 37, 39, 40, 42-45, 65-67, 70, 73, 74, and 117 are allowed.

4. The following is a statement of reasons for the indication of allowable subject matter:

The present invention is directed to a system and method for distributed content item from the distribution server to portable terminal by use of client terminal. Claims 1, 19, 37, 65 and 70 uniquely identify a distinct feature "after client terminal receives a trial content item from distribution server, the client terminal request the distribution server to send a regular content to the portable terminal wherein the portable terminal to which the regular content item is distributed from the distribution server being specified by destination information which is transmitted from the client terminal to distribution server on the basis of input screen data transmitted from the distribution server to the client terminal upon a request to distribute regular content item" and in combination with other limitations as set forth in the independent claims. Claims 3, 4, 6-9, 17, 18, 21, 22, 24-27, 39, 40, 42-45, 66, 67, 73, 74, and 117 are allowed due to dependent claims.
