Specification

The abstract of the disclosure is objected to because it contains more than 150 words. Correction is required. See MPEP § 608.01(b).

Claim Rejections - 35 USC § 112

The following is a quotation of the first paragraph of 35 U.S.C. 112:

The specification shall contain a written description of the invention, and of the manner and process of making and using it, in such full, clear, concise, and exact terms as to enable any person skilled in the art to which it pertains, or with which it is most nearly connected, to make and use the same and shall set forth the best mode contemplated by the inventor of carrying out his invention.

Claims 1 and 2 are rejected under 35 U.S.C. 112, first paragraph, as failing to comply with the enablement requirement. The claim(s) contains subject matter which was not described in the specification in such a way as to enable one skilled in the art to which it pertains, or with which it is most nearly connected, to make and/or use the invention.

The second switching state is first said to enable lifting and lowering of the forks of a forklift truck. See the passage starting on line 10 starting with " that lifts..." and ending on line 11 with " in a second switching state". The next passage of the claim states that the lifting and lowering of the fork is not enabled while the switch is in the second switching state. Since the specification is not enabling for the second switching state to both enable and disable the lifting and lowering of the forks, it is not possible for the examiner to determine the intended scope of the claim. Claim 2 is also rejected as being dependent upon an unenabled claim. As claim 1 is not able to be examined at this

time, claim 2 is also unable to be examined as its scope indeterminate as well. Therefore claims 1 and 2 have not been treated on the merits at this time.

Response to Amendment

The amendments filed on April 24, 2003 have been entered into the record.

Allowable Subject Matter

The following is a statement of reasons for the indication of allowable subject matter: Claim 3 has allowable subject matter, namely the relationship between the operating lever, a switch and a controller, and how they combine to generate a signal for a control valve. The previously cited prior art of Momota does not teach or suggest the combination of features as claimed in independent claims 1 and 3.

Claims 4-9 are dependent upon claim 3 and are in condition for allowance.

Response to Arguments

Applicant's arguments with respect to claim 1 have been considered but are moot in view of the new ground(s) of rejection.

Terminal Disclaimer

The terminal disclaimer filed on April 24, 2003 disclaiming the terminal portion of any patent granted on this application which would extend beyond the expiration date of U.S. Patent 6,273,669 has been reviewed and is accepted. The terminal disclaimer has been recorded.
