DETAILED ACTION

1. The reply filed on 31 January 2005 is not fully responsive to the prior Office Action because of the following omission(s) or matter(s):

In the Office action mailed 12 November 2004, claim 2 was rejected based on the usage of the trademark WINDOWS NT rendering the claim indefinite under 35 U.S.C. §112, second paragraph.

Applicant has not only failed to appropriately address this issue, but has exacerbated the problem by adding further improper references to the aforementioned trademark (in amended claims 2, 3, 5, and 7-9). It is noted that Applicant has not accompanied the amendments to the claims with any argument suggesting that the §112 rejection had been made in error or otherwise attempted to justify the amendments involving the trademark. Applicant's remarks are a nearly identical copy of the remarks submitted 31 January 2005; only the date has apparently been changed.

Additionally, Applicant's specification refers to a WINDOWS 2000® operating system. However, it is noted that WINDOWS 2000 is not a registered trademark (WINDOWS is a registered trademark, however, and recitation of "WINDOWS® 2000 operating system" would be more appropriate).


