Continuation of 2. NOTE: The proposed amendment would require further searches and further considerations under 35 USC 102 or 35 USC 103 because SEQ ID NO:1 had not been previously presented nor searched. Applicant's after-final response is that SEQ ID NO:1 and Genbank accession number XP\_011828 are the same. However, prior to Applicant's response, there was no way of knowing if these sequences were indeed the same since accession numbers are subject to changes and updates in the sequences. Hence, prior to the after-final response, any search of XP\_011828 would not have demonstrated possession of the proposed amended claims.
