The claims have been amended as follows:

6. (currently amended) A method for determining whether a subject has a defect in cell proliferation comprising assaying a diagnostic sample of the subject for GLUTx expression wherein detection of GLUTx expression elevated above normal is diagnostic of a defect in cell proliferation, wherein the defect in cell proliferation is a mammary adenocarcinoma or an endometrial adenocarcinoma, wherein GLUTx protein has consists of the amino acid sequence set forth in SEQ ID NO:1, and wherein the diagnostic sample is assayed using an antibody that specifically binds to GLUTx protein.

8. (currently amended) A method for determining whether a subject has a defect in cell proliferation comprising assaying a diagnostic sample of the subject for GLUTx expression wherein detection of GLUTx expression elevated above normal is diagnostic of a defect in cell

proliferation, wherein the defect in cell proliferation is a mammary adenocarcinoma or an endometrial adenocarcinoma, wherein GLUTx protein ~~has~~ consists of the amino acid sequence set forth in SEQ ID NO:1, and wherein the diagnostic sample is assayed using at least one nucleic acid probe that specifically hybridizes to nucleic acid encoding GLUTx.
