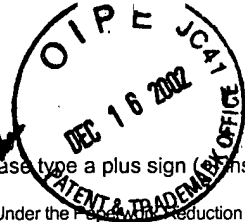

Information Disclosure Statement


