
Foreign patent document WO 97/35573 (The Boots Co., published October 2, 1997) was cited in the Office Action issued on July 13, 2009 in US App. 11/667,325, discussed further below.

An Office Action issued in US App. 09/284,683 on July 23, 2009 includes rejections under 35 USC 112 and under 35 USC 103 in view of Vyas (J. Microencapsulation, 1995) or Hayward (5,585,109) or Sheffield (4,937,254) in combination with Radhakrishnan (5,043,165), Edgar (5,498,420) by themselves or further in combination with Mezei (4,897,269).

An Office Action issued in US App. 11/667,325 on July 13, 2009 includes rejections under 35 USC 112 and under 103 in view of Cevc 2004/0071767 and Speight (WO 97/35573). The Examiner also mentions Rovee (US 4,185,100) at page 10 numbered paragraph 10 of the Action.

Documents Holum, Stryer and Mathew & van Holde were submitted in a communication filed in this application on July 13, 2009 and in a communication filed in U.S. App. No. 09/890,335 (identified as copending on page 1 of the present application) on July 14, 2009.
