Claim **101**, line 1, at the start of the sentence, delete 'A' and replace with 'A plant cell having a'.

Claim **102**, line 1, at the start of the sentence, delete 'A' and replace with 'A transgenic plant having a'.

Claim **104**, line 1, at the start of the sentence, delete 'Progeny' and replace with 'Seed and plant'.

This Application provides novel *Synechocystis* PCC 6803 polynucleotides of SEQ ID NO: 6 and 17 encoding acetohydroxy acid synthase (AHAS) large and small subunits respectively, vector, host cell, plant transformation and a process of producing the enzyme recombinantly.


No prior art reference or sequence of record, however, taken alone or in combination teach the claimed invention or provide motivation to one of ordinary skill in the art to use the skills available in the area of enzymology or molecular biology, to make the invention obvious.
