DETAILED ACTION

Specification

The incorporation of essential material in the specification by reference to a foreign application or patent, or to a publication is improper. Applicant is required to amend the disclosure to include the material incorporated by reference. The amendment must be accompanied by an affidavit or declaration executed by the applicant, or a practitioner representing the applicant, stating that the amendatory material consists of the same material incorporated by reference in the referencing application. See *In re Hawkins*, 486 F.2d 569, 179 USPQ 157 (CCPA 1973); *In re Hawkins*, 486 F.2d 579, 179 USPQ 163 (CCPA 1973); and *In re Hawkins*, 486 F.2d 577, 179 USPQ 167 (CCPA 1973).

The Examiner acknowledges Applicant's response indicating that all of the essential material is recited within the instant application, given that, Applicant is advised to delete the language in the specification improperly incorporating material from the foreign application.

Claim Rejections - 35 USC § 102

The following is a quotation of the appropriate paragraphs of 35 U.S.C. 102 that form the basis for the rejections under this section made in this Office action:

A person shall be entitled to a patent unless –

(b) the invention was patented or described in a printed publication in this or a foreign country or in public use or on sale in this country, more than one year prior to the date of application for patent in the United States.

(e) the invention was described in (1) an application for patent, published under section 122(b), by another filed in the United States before the invention by the applicant for patent or (2) a patent granted on an application for patent by another filed in the United States before the invention by the applicant for patent, except that an international application filed under

the treaty defined in section 351(a) shall have the effects for purposes of this subsection of an application filed in the United States only if the international application designated the United States and was published under Article 21(2) of such treaty in the English language.

Claims 1-2, 7 and 13 are rejected under 35 U.S.C. 102(b) as being anticipated by Dane et al., U.S. patent No. 5,843,387.

Dane et al., teach an apparatus for containing an endoscope for steam sterilization, having a resilient force preventing means which surround a portion of the endoscope to support and protect it.

Claims 1-13 are rejected under 35 U.S.C. 102(b) as being anticipated by Hillebrenner et al., U.S. patent No. 5,534,221.

Hillebrenner et al., set forth a container for endoscope sterilization wherein both a tray and lid are provided, with each having a recessed means for predetermined placement and protection of the endoscope with means to prevent different areas of the endoscope to touch during treatment. See column 2, lines 40-45 and 55-62, column 3, lines 1-6, and 10-20 and 29-36, and column 6, lines 10-60, column 7, 64-68, and finally column 10, lines 60-65.

Double Patenting

Claims 8 and 10-12 are provisionally rejected under the judicially created doctrine of obviousness-type double patenting as being unpatentable over claims 1-10 of copending Application No. 09/919190. Although the conflicting claims are not identical, they are not patentably distinct from each other because they are both directed to means for maintaining an endoscope in a predetermined shape.

This is a provisional obviousness-type double patenting rejection because the conflicting claims have not in fact been patented.

Response to Arguments

Applicant's arguments filed 11/15/2004 have been fully considered but they are not persuasive. Applicant argues that the structure of Dane itself requires a press fitting of the instrument therein, however the Examiner would disagree and point to Figs. 5 and 7 clearly showing the instrument supported within a cushioning structure, not fit therein. Applicant further argues that Hillebrenner is interpreted correctly by the Examiner, but that the structure itself would apply "pressing forces" to the endoscope, the Examiner would respond by pointing out that the claims fail to require protect for all pressing forces, and the structure of Hillebrenner prevents pressing contact between sections of the instrument.
