EXAMINER'S AMENDMENT

1. An examiner's amendment to the record appears below. Should the changes and/or additions be unacceptable to applicant, an amendment may be filed as provided by 37 CFR 1.312. To ensure consideration of such an amendment, it **MUST** be submitted no later than the payment of the issue fee.

Authorization for this examiner's amendment was given in a telephone interview with Joseph D'Angelo (Reg. No. 56,800) on 6/12/2009.

The application has been amended as follows:

a) Claim 1: 1) replace "the transmission packet is a write packet, copying" with -the transmission packet is a write packet, automatically choosing said alternate path and copying- in line 12; and

2) replace "a virtual network interface process wherein" with -a virtual network interface process which can be shutdown upon receipt of a shutdown request, wherein- in line 18.

b) Claim 11: 1) replace "the unavailability of the network, writing" with -the unavailability of the network, automatically choosing an alternate path and writing- in line 7;

2) replace "via an alternate path" with -via said alternate path- in line 14;
and

3) replace "a virtual network interface process wherein" with -a virtual network interface process which can be shutdown upon receipt of a shutdown request, wherein- in line 15.

2. Any comments considered necessary by applicant must be submitted no later than the payment of the issue fee and, to avoid processing delays, should preferably accompany the issue fee. Such submissions should be clearly labeled "Comments on Statement of Reasons for Allowance."

Conclusion

3. The prior art made of record and not relied upon is considered pertinent to applicant's disclosure. Yamagami (US patent No. 7,275,100 B2) discloses an alternate path for transferring a heartbeat signal.
