DETAILED ACTION

Allowable Subject Matter

1. Claims 1-7, 12-14, and 32 are allowed.

Reasons for Allowance

2. The following is an examiner's statement of reasons for allowance:

Regarding claims 1, 13, and 32, the prior art reference to Brown (5771435) teaches processing a user request for a VOD version of a program if the system's resources would not be constrained. The prior art reference to Young (4706121) teaches the program guide displays available listings and does not display listing which are unavailable. The prior art reference to livonen (7246367) teaches the server monitors and keeps track of the playback status of streams transmitted to the user in real-time. The prior art of record fails to teach or fairly suggest presenting a program guide including bi-directional services, wherein the availability information includes one of available or unavailable, and populating and presenting an updated bi-directional services program guide to reflect the availability information when a service has been rendered to a user.
