REQUEST FOR RECONSIDERATION/OTHER

The request for reconsideration has been considered but does NOT place the application in condition for allowance because: The arguments are not persuasive (see pages 6-7) of office action, Paper #7. The argument that Gallagher in view of Grewal does not contain a reference to context sensitive help does not overcome the rejection because the definition of context sensitive help is help that is intelligent help that a user can access directly from the software application (google = define" context sensitive help). Gallagher expressly teaches a help feature accessible directly from the application in providing HTML links to error messages with descriptive help. Additionally, Grewal expressly shows a feature of connecting a user with a domain expert via a chat session in which a free form contextual conversation can transpire. In the spirit of a chat session, information is sent from a first computer to a second computer.
