1. A request for continued examination under 37 CFR 1.114, including the fee set forth in 37 CFR 1.17(e), was filed in this application after final rejection. Since this application is eligible for continued examination under 37 CFR 1.114, and the fee set forth in 37 CFR 1.17(e) has been timely paid, the finality of the previous Office action has been withdrawn pursuant to 37 CFR 1.114. Applicant's submission filed on 1/20/04 has been entered.

2. The following is a quotation of the appropriate paragraphs of 35 U.S.C. §102 that form the basis for the rejections under this section made in this Office action:

A person shall be entitled to a patent unless --

(a) the invention was known or used by others in this country, or patented or described in a printed publication in this or a foreign country, before the invention thereof by the applicant for a patent.

(b) the invention was patented or described in a printed publication in this or a foreign country or in public use or on sale in this country, more than one year prior to the date of application for patent in the United States.

(e) the invention was described in a patent granted on an application for patent by another filed in the United States before the invention thereof by the applicant for patent, or on an international application by another who has fulfilled the requirements of paragraphs (1), (2), and (4) of

section 371(c) of this title before the invention thereof by the applicant for patent.

3. Claims 21-41 are rejected under 35 U.S.C. §102(b) as being anticipated by White.

See Fig. 7B and Fig. 18 with Fig. 7B being illustrative of the elevations of the different surfaces of the bottom face of the slider relative to the top surface of the slider.

Note, to the extent claimed and understood, the structure as shown in Addendum C reads on and performs to the same degree as claimed.

Further note that applicant's specification and figures 3 and 6 indicate that the air bearing surface(400) and the first surface(440/640) are the same surface and/or at the same elevation.

Re claims 29-41 since all sliders have a center of gravity somewhere near the geometrical center of same and also since the term "proximate" is only an approximate locator, any center of gravity near or close to the geometrical center of White's slider would fulfill the requirements of these instant claims.

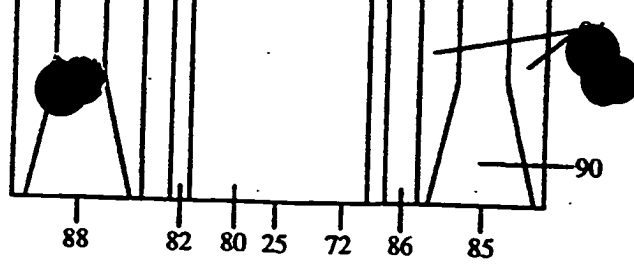

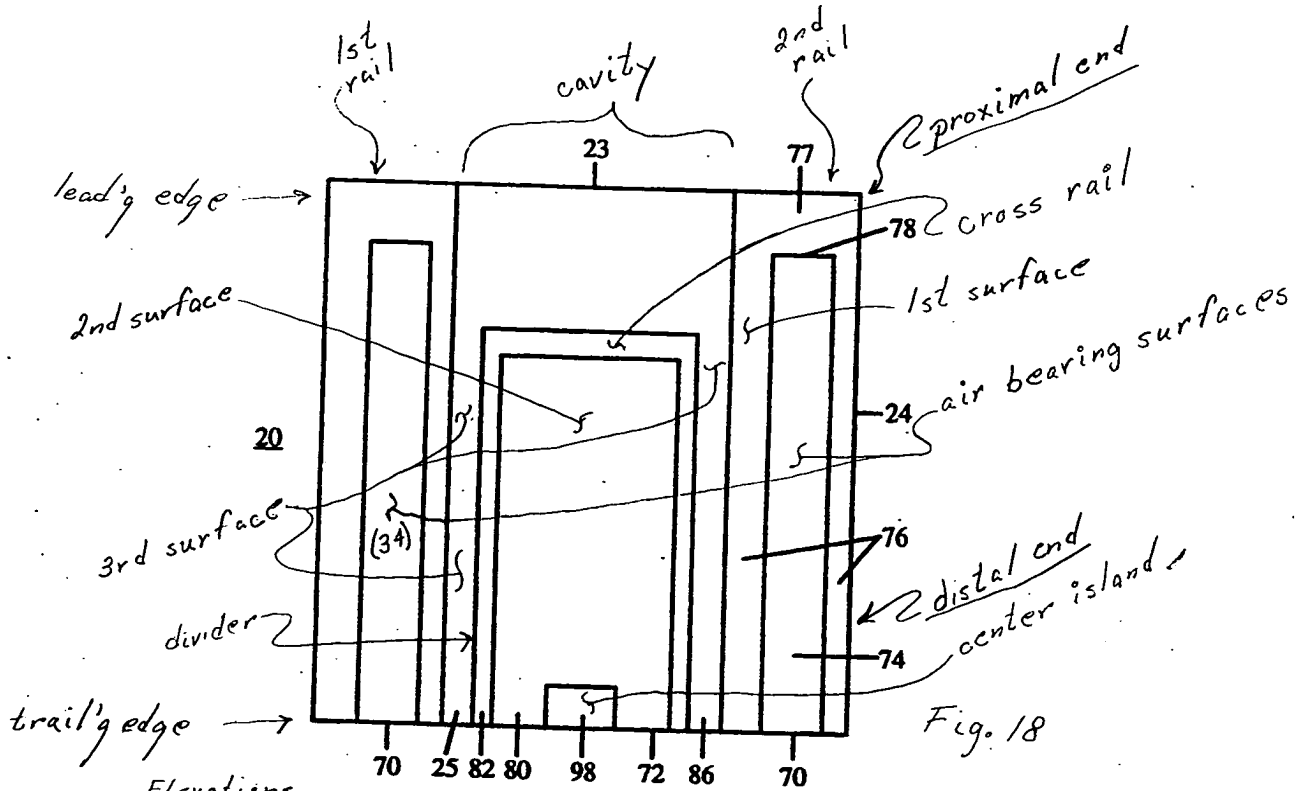

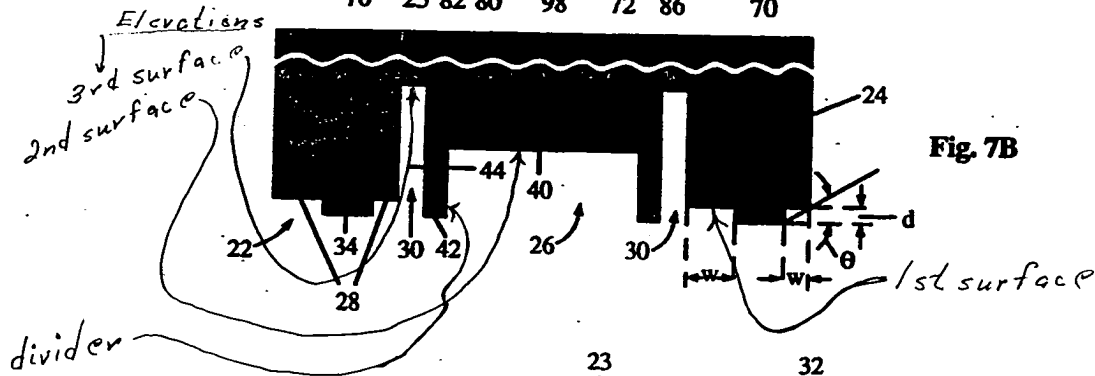
