Continuation of 10. Other: in the response to the "Final Office Action (paper 11)", the applicant asserts that stainless steel is not a highly radiopaque material in comparison to other metal such as a tungsten. However, "highly radiopaque" are relative terms and a stainless steel can be considered as a highly radiopaque material in comparison to other material such as a polymer or a nitinol. Claim 1 of the invention claims "a first wire" and "a second highly radiopaque metal wire". Since the "first wire" can be a polymeric wire/nitinol wire, and the "second highly radiopaque metal wire" can be a stainless steel, the TRUCKAI (US Pat. 5,019,057) "second stainless steel wire" as mentioned in the "Final Office Action" can be considered as the "second highly radiopaque metal wire" as recited in the claim. Therefore, at least claim 1 of the instant invention is not clearly defined over TRUCKAI (US Pat. 5,019,057).
