### **Reasons for Allowance**

Applicants' response to the last Office Action, filed on August 12, 2005 has been entered and made of record.

The following is an examiner's statement of reasons for allowance:

Independent claims 1, 9, and 10 are allowable over the prior art of record. Claims 3-8 depend from claim 1, therefore, are allowed.

Independent claims 1, 9, and 10 recite the limitations of : a start of dyeing coloring agent is controlled by a user independently with respect to each of the first line, the second lines and the third lines. The combination of these features as cited in the claims in combination with the other limitations of the claims, are neither disclosed nor suggested by the prior art of record.

The closest references of US 5982990 to Condek discloses a method of creating a table for dyeing color agent for a plurality of lines. However, he does not teach the limitations of cited above.

In view of the amended claims and the Applicant's arguments , the rejections and objections to claims 2-~~7~~, 8-10 are expressly withdrawn.
