
I, Stephen Argenbright, hereby state:

discovered in that search have been previously provided to the Patent and Trademark Office in this application.

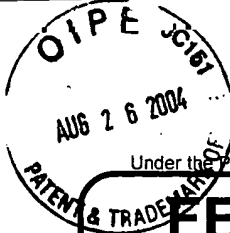
