DETAILED ACTION

Election/Restrictions

Restriction is required under 35 U.S.C. 121 and 372.

This application contains the following inventions or groups of inventions which are not so linked as to form a single general inventive concept under PCT Rule 13.1.

In accordance with 37 CFR 1.499, applicant is required, in reply to this action, to elect a single invention to which the claims must be restricted.

Group 1, claim(s) 1, 2, and 5-14, drawn to compositions comprising an 8 nucleobase portion of SEQ ID NOS: 32 or 21, and modifications thereof.

Group 2, claim(s) 15-18, drawn to methods of inhibiting the expression of AKT-2 comprising administering a composition comprising an 8 nucleobase portion of SEQ ID NOS: 32 or 21.

The inventions listed as Groups I and II do not relate to a single general inventive concept under PCT Rule 13.1 because, under PCT Rule 13.2, they lack the same or corresponding special technical features for the following reasons: The claims lack unity. Claims are considered to lack unity when the claimed special technical feature does not constitute a contribution over the prior art. In this case, the special technical feature is an antisense molecule targeted to AKT-2. Draper *et al.* teaches an oligo that comprises an 8 nucleobase portion of SEQ ID NO: 21 targeted to AKT-2 (SEQ ID NO: 206). Thus, the oligo of Draper is considered to teach the instantly claimed special technical feature, and accordingly the claims as presently recited are considered to lack unity of invention because the claimed special technical feature is not considered a contribution over the prior art.

Applicant is advised that the reply to this requirement to be complete must include an election of the invention to be examined even though the requirement be traversed (37 CFR 1.143).

Applicant is reminded that upon the cancellation of claims to a non-elected invention, the inventorship must be amended in compliance with 37 CFR 1.48(b) if one or more of the

currently named inventors is no longer an inventor of at least one claim remaining in the application. Any amendment of inventorship must be accompanied by a request under 37 CFR 1.48(b) and by the fee required under 37 CFR 1.17(i).
