ADVISORY ACTION

Acknowledgement of Applicant's Amendments

1. The amendments made in claims 1, 5, and 10 in Paper #10 have not been entered due to the fact that they raise new issues that would require further consideration and/or search. The limitation added to claim 1, that the amount of quaternary ammonium compound is based on the self-sustaining film rather than the composition, raises new issues because further search is required. Also the limitations added to claims 5 and 10, in which the composition is changed from open language to closed language raises new issues because further consideration is required to determine if the closed language presents new matter and whether the prior art is overcome from an obvious standpoint.

ANSWERS TO APPLICANT'S ARGUMENTS

2. All of the arguments presented in Paper #10 are directed toward the newly amended limitations, which were not entered, therefore the arguments are determined to be moot based on the non-entered amendment.




