### EXAMINER'S AMENDMENT

The application has been amended as follows:

- In claim 24, line 1, "as claimed in Claim 23" has been changed to -- as claimed in Claim 19--.
- Claim 25 has been cancelled.
- In claim 35, lines 2 and 3, "having an end portion which is detachably fastened to the brake housing" has been replaced with -- . --.
- In claim 36, lines 2 and 3, "having an end portion which is detachably fastened to the brake housing" has been deleted.
- In claim 37, lines 2 and 3, "having an end portion which is detachably fastened to the brake housing" has been deleted.
- In claim 38, lines 2-4 have been replaced with -- wherein said two spring arms of the spring assembly is conformed to an "S" shape.--
- In claim 43, lines 26-28 have been replaced with -- radial top side of the housing, thereby fixing the spring assembly in one of a circumferentially and a radially

accurate position on the brake housing, wherein the pocket is shaped during casting fabrication of the brake housing.--

2. The following is an examiner's statement of reasons for allowance: Applicant's argument filed 12/3/04 has been found to be persuasive. It is recognized that the claimed feature of the spring assembly includes a second leg portion supported in a circumferential direction on the brake housing by two spring arms supported in the recess to define over the prior art of record.

Any comments considered necessary by applicant must be submitted no later than the payment of the issue fee and, to avoid processing delays, should preferably accompany the issue fee. Such submissions should be clearly labeled "Comments on Statement of Reasons for Allowance."
