- 1) Applicant amendment and response filed 12/08/2005 are acknowledged and entered.
- 2) The reply filed on 12/08/2005 is not fully responsive to the prior Office Action because of the following omission(s) or matter(s): Applicant's amendment to the independent claim 69 and newly added independent claim 145 include the limitation that is drawn to a non-elected species, i.e. the limitation of "an artificial enzyme variant". Applicant is respectfully reminded that applicant has elected enzymes having specificity for metabolite, i.e. claim 131, for the single specific species of enzyme in the response filed 04/07/2005. Consequently, these independent claims 69 and 145 would be withdrawn as being drawn to a non-elected species. Moreover, this limitation, i.e. an "enzyme variant", is recited in the withdrawn dependent claims 136 and 138. Therefore, the amendment filed 12/08/2005 is considered not fully responsive to the prior Office Action mailed 06/09/2005. See 37 CFR 1.111.
