B1 – Published Japanese Utility Model Publication No. 63-039297

JP 63-039297 appears to disclose a mechanical connection between a substantially planar member 1 and a frame member 3. The connection is made by means of at least one nail 4 that pierces and elongated subsidiary material 3 that has a shearing force greater than that of the planar member 1 and that is disposed near the edge of the planar member 1. The nail 4 terminates within the frame member 3.
