Allowable Subject Matter

1. Claim 9 is allowed.
2. The following is an examiner's statement of reasons for allowance:

The prior art, Peterson (US 5,857,020), discloses an accounting system having an accounting center and a terminal device. The terminal device comprises a first memory, a second memory, a first controller, and a second controller, wherein the controller updates the attributes of the distributed information and the accounting points stored in the first memory based upon the distributed information. When accounting points are updated correctly the controller updates attributes of the distributed information. The accounting center comprises a third controller (the personal computer ("PC")) adapted to carry out an account processing based upon the accounting points transmitted from the terminal device.

The prior art fails to disclose the system to include a portable device connected to the terminal device, wherein a controller updates attributes on the portable device, or a detector configured to detect the presence of the portable device.

The limitations lacking in the prior art, in combination with the other limitations clearly claimed for patent, are novel and unobvious.
