***Allowable Subject Matter***

1. Claims 1, 6-10, 12-22, 30-32, 35-38 are allowed.
2. The following is a statement of reasons for the indication of allowable subject matter: Prior art of record fails to teach generating an annotation showing dimension between a first entity in the first position and the first entity in the second position. Prior art (5815154, Hirschtick) does teach annotation showing dimensions between different entities. However there is no motivation to modify to this to just one movable entity shown at different positions. Also prior art fails to teach wherein the model hierarchy comprises the first one of the model component in a first position and the first one of the model component in a second position and then combining the two different views of the one of the model component to display a composite image of the model and storing dimension datum in the model hierarchy referring to a first view entity and a second view entity of one of model components and calculating a dimension between a first entity in the first view and the first entity in the second view. Prior art teaches calculating the dimensions for two different entities.
