DETAILED ACTION

Authorization for this examiner's amendment was given in a telephone interview with David Oldenkamp on 9/27/04.

Cancel claim 39.

CLAIMS DRAWN TO A NON-ELECTED INVENTION.

Applicants' election of Group I (claims 1-20, 30, 31, and 37-40) in the reply filed on 7/23/04 is acknowledged. Because applicantS did not distinctly and specifically point out the supposed errors in the restriction requirement, the election has been treated as an election without traverse (MPEP § 818.03(a)).

An examiner's amendment to the record appears below. Should the changes and/or additions be unacceptable to applicantS, an amendment may be filed as provided by 37 CFR 1.312. To ensure consideration of such an amendment, it MUST be submitted no later than the payment of the issue fee.

This application is in condition for allowance except for the presence of claims 21-29 and 32-36, drawn to Group II claims non-elected without traverse. Accordingly, claims 21-29 and 32-36 have been cancelled.

The following is an examiner's statement of reasons for allowance:

The instant invention is directed to a method for the colocalization of two or more species of interest via excited light emission wherein the sample is moved a predetermined distance a predetermined number of times to create a multitude of representations which are then utilized to measure a distance between the species of interest via the distance measured between geometric centers of the representations.

The closest prior art of record is that of Weiss et al. [Proceedings of the Natl. Acad. Sci, USA 94:520 (1997)] which colocalizes proteins in erythrocytes but does not described the above noted sample movements or distance measurements via geometric centers of representations of the moved samples.
