EXAMINER'S AMENDMENT

1. An examiner's amendment to the record appears below. Should the changes and/or additions be unacceptable to applicant, an amendment may be filed as provided by 37 CFR 1.312. To ensure consideration of such an amendment, it MUST be submitted no later than the payment of the issue fee.

Authorization for this examiner's amendment was given in a telephone interview with Grant Langton on December 21, 2004.

The application has been amended as follows:

Claim 42 has been cancelled as it does not further limit independent claim 38.

Specification, page-1, in line-8, after "1998" (see preliminary amendment of August 7, 2001), the phrase --, now U.S. Patent No. 6,270,871 - - has been inserted.

Abstract, starting in line-15 and ending in line 23, the phrase "The overlaminated film ... pressure sensitive adhesive construction" has been deleted to conform to the size of 150 words.

The PTO-1449 form of Information Disclosure Statement (IDS) filed on January 4, 2002 is being resent to the applicant because one foreign document and the "other documents" that were not initialed but are now initialed.

REASONS FOR ALLOWANCE

2. The following is an examiner's statement of reasons for allowance:

A review of applicant's arguments in amendment filed on December 8, 2004 and a review of the instant amended claims has convinced the examiner that the claims are

allowable over the applied prior art of record. The prior art fails to teach or suggest a method of forming a pressure sensitive adhesive (PSA) construction comprising applying a layer of PSA to a release surface of a substrate, simultaneously in a single step applying a film-forming material on the PSA surface to form a continuous film thereover and render the PSA tack-free, wherein the film-forming material has a viscosity that is within the range of viscosities that is compatible with the viscosity of the PSA at a shear rate of approximately 40,000 / s and at a given application temperature, laminating an overlamine film layer onto the continuous film, and forming a printed indicia onto the continuous film or the backside of the overlamine. Also, no evidentiary support could be provide to support the position that the instant claimed invention would be obvious over the prior art of record.
