The rejection is maintained for the reasons given in the previous office actions, those are summarized below:

Engman et al disclosed a method for reduction of a substrate with thioredoxin reductase, comprising combining the thioredoxin reductase, the substrate, selenium compound and NADPH in vitro conditions to reduce the substrate, wherein the substrate is thioredoxin and the selenium compound [see Table 1, page 4601] is a "competitive inhibitor" for the thioredoxin [see Results]. Engman et al also disclose selenium in the form of selenite (selenium compound) is a substrate for the reduction by mammalian thioredoxin reductase [page 4600, 2nd paragraph]. Please note that a competitive inhibitor is also a substrate. A competitive inhibitor competes with the substrate for the same binding site on the enzyme. Therefore, in addition to Engman disclosure [page 4600, 2nd paragraph], the selenium compound disclosed by Engman is a substrate for thioredoxin reductase.
